## SECTION 4: First aid measures

### 4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If unconscious, put the person in the stabilized (recovery) position on his side with his head slightly bent backwards and make sure that airways are free; never induce vomiting. If the person vomits by himself, make sure that the vomit is not inhaled. In life threatening conditions first of all provide resuscitation of the affected person and ensure medical assistance. Respiratory arrest - provide artificial respiration immediately. Cardiac arrest - provide indirect cardiac massage immediately.

Rinse eyes immediately with a flow of running water, open the eyelids (also using force if needed); remove contact lenses immediately if worn by the affected person. Rinsing should continue at least for 10 minutes. Provide medical treatment, specialized if possible.

### SECTION 7: Handling and storage

#### 7.1. Precautions for safe handling

Prevent formation of gases and vapours in flammable or explosive concentrations and concentrations exceeding the occupational exposure limits. The product should be used only in the areas where it is not in contact with open fire and other ignition sources. Use non-sparking tools. Use of antistatic clothes and footwear is recommended. 
